## Conditions for the granting of rights to the free use of the software DIGSI 5 Scientific (hereinafter referred to as "software product")

Siemens grants the licensee the royalty-free, non-exclusive and non-transferable right, not limited in time and/or place, to use the software product provided in object code for exclusively internal research and testing purposes, and to duplicate it to the extent required for the installation, loading, displaying, execution and storing of the software. There shall be no right for the source code to be made available. This shall not apply to source codes of open-source software with license conditions which require the availability of the source code. If the software product contains open-source software, this open-source software is listed in the Readme\_Open Source Software directory of the open-source software. The license shall be entitled to use the open-source software under the relevant licensing conditions of the open-source software product. The license conditions of the relevant open-source software shall take precedence in terms of validity. If the license conditions of the OSS require the source code of said OSS to be made available, Siemens shall make this source code available on request, charging a fee for shipping and handling.

The licensee shall not, without the prior written consent of Siemens, reproduce the software product or documentation beyond the agreed scope, nor shall it modify, reverse engineer or decompile the software or separate any part thereof, to the extent that this is not explicitly permitted under the provisions of copyright law.

The licensee shall not remove the copyright information, alphanumeric identifiers, trademarks or brands present in the respective software product, on the data carrier, or in the documentation. When copying is permitted, the licensee shall not remove the aforementioned items, nor change them in the copies, and shall assign a consecutive number to all copies, from which the software serial numbers can be discerned, and shall provide a record of the whereabouts of all copies, which Siemens shall be entitled to view on request.

Siemens shall not be obliged to provide UPDATES and/or UPGRADES.

The licensee shall comply with all applicable export regulations. In particular, the licensee shall not, neither directly nor indirectly, export or re-export the licensed software product and/or documentation in any manner contrary to German, U.S. or other export regulations.

The licensee shall indemnify Siemens in respect of any claims made against Siemens in connection with compliance with export regulations.
