

## **Data Privacy Policy**

The protection of personal data is very important to us. In the following, we tell you which information we might possibly collect, how we handle that information and with whom the information may be shared by the various Siemens companies in the USA ("Siemens USA").

### **Personal data**

Through this application, Siemens USA will not directly collect any personal data about you (such as your name, address, telephone number or e-mail address), unless you voluntarily choose to provide it (such as by registration or survey), or unless otherwise required by applicable laws and regulations. From time to time, we may also collect personal data about you indirectly from other sources. The information that we collect from various sources may be combined.

### **Communication-related or usage-related data**

When you access our application via telecommunications services, communication-related data (e.g., Internet Protocol address) and usage-related data (e.g., data on the commencement and duration of usage and on the telecommunications services used by you) are automatically generated by technical means. This data could possibly enable the telecommunications provider to draw inferences concerning your personal data. We have no access to this information. Whenever it is absolutely necessary to collect, process and use your communication-related or usage-related data, such activity is conducted in compliance with the laws and regulations applicable to data protection.

### **Automatically collected non-personal data**

When you access our application, information may sometimes be automatically collected (thus, not by way of registration), which is not attributable to a certain person (e.g., operating system used; number of visits; average duration of visit; publications retrieved). We use this information to assess the attractiveness of our application and to improve its performance and content.

### **Purpose of Use; Sharing**

Siemens may collect and then use your personal data to respond to your inquiry or request, to process your order or to provide you with access to specific information or offers, as well as to support our existing or potential customer relationship with you. Siemens may store and process personal data (on our own or via a third party on our behalf) and share it with our worldwide affiliates to understand better your business needs and how to implement and improve our business practices, products and services. We (or a third party on our behalf) may use personal data to contact you about an offer in support of your business needs or to conduct online surveys to understand better our customers' needs. We may share your personal information with our US and worldwide affiliates (meaning entities controlled by, controlling, or under common control with Siemens). We may collect, use, disclose, and share your information:

- as provided herein, or with your consent, or where it is necessary to carry out your instructions or to prepare, negotiate or perform a contract with you;
- as reasonably necessary to provide our features and functionality to you;
- to create and administer your account;
- to verify your identity in connection with the other purposes listed here;
- communicate with you regarding employment;
- when we reasonably believe it is required by law or governmental or judicial authorities;

- as reasonably necessary to enforce our Terms of Use, to establish or preserve a legal claim or defense, to prevent fraud or other illegal activities, including attacks on Siemens' information technology systems, or protect the rights of Siemens or others;
- for those purposes that were identified at the time the data was collected; and/or
- for any additional purpose that is directly related to the original purpose for which the personal data was collected.

We may employ third party companies and individuals to host or support our Internet sites, mobile applications, or the services to which they relate. These third parties may have access to your information to perform such tasks. We do not sell or otherwise market your personal data to other third parties, except to as described. We suggest you read our third party's privacy policies for more information on their data handling practices.

To the extent required to help us fulfill your orders or requests, we may share personal data with others, such as our business partners, postal/logistics companies, or customs agents/authorities.

We may transfer your information and process it outside your country of residence. We may transfer your information if we sell or transfer all or part portion of our business or assets.

## **Information Stored Automatically on Your Computer or Device**

When you view one of our Internet sites or use this application, we may store some data on your computer or device in the form of a unique identifier or "cookie" to recognize automatically your computer or device the next time you visit. Cookies can help us in many ways, such as by allowing us to tailor an Internet site to match your interests better or to store your password to save you having to re-enter it each time. By using this application, you consent to the placement of cookies in your device in accordance with this Privacy Policy. If you do not wish to receive cookies, please configure your device to erase all cookies from your device, to block all cookies, or to receive a warning before a cookie is stored. If you do decide to block cookies, you may not be able to take advantage of all of the application's features.

Our Internet sites and mobile applications may, in our discretion, be configured to allow collection of personally identifiable information over time and across different Internet sites about an individual's online activities.

## **Links to other websites**

The Siemens application contains links to Siemens websites, which themselves contain links to other websites. Siemens is not responsible for the data protection policies or content of these other websites.

## **International Data Transfer**

Siemens USA. may transfer your personal data to its parent Company in Germany, Siemens AG, and to any other Siemens group company worldwide when processing data. We may also transfer your data to a third party outside your country of origin. Siemens has entered into a Binding Corporate Rules framework which governs the treatment of personal information of European Union residents. ## **Children**

This application is not directed to children under the age of thirteen. We will not knowingly collect personal data via this application from children under the age of thirteen without insisting that

they seek prior parental consent if required by applicable law. We will only use or disclose personal data about a child to the extent permitted by law, to seek parental consent, pursuant to local law and regulations or to protect a child.

## **Security**

To protect your personal data against accidental or unlawful destruction, loss, use, or alteration and against unauthorized disclosure or access, Siemens uses reasonable physical, technical and organizational security measures. Unfortunately, there is no complete assurance of security in transit or storage to any information that you transmit, no complete assurance that information will not be accessed, disclosed, altered, or destroyed by a breach of any of our physical, technical, or organizational measures.

## **California Privacy Rights**

California's "Shine The Light" law permits those of our customers who are California residents to annually request a list of their personal information (if any) that we disclosed to third parties for direct marketing purposes in the preceding calendar year, and the names and addresses of those third parties. At this time, we currently do not share any personal information with third parties for their direct marketing purposes.
