In the time period from 12 July 2021 until and including 18 July 2021, a number of 3,706 shares were bought back within the framework of the share buyback of Siemens Aktiengesellschaft; on 3 December 2018, Siemens Aktiengesellschaft disclosed pursuant to art. 5 para. 1 lit. a) of the Regulation (EU) no. 596/2014 and art. 2 para. 1 of the Delegated Regulation (EU) no. 2016/1052 the begin of the share buyback on 3 December 2018.
