

## Siemens offers full support to employees with COVID-19 vaccination incentives

- **Siemens introduces measures in support of the COVID-19 vaccine drive**
- **Initiatives include two days of paid vaccination leave, health talk, lucky draw perks, vaccine insurance coverage and annual medical check**

In addition to the free annual medical check for employees, extra vaccination side-effect coverage is also included in the company insurance, and all vaccinated employees are entitled to enter a lucky draw to win prizes. Getting the COVID-19 vaccination is completely voluntary, and Siemens is offering its full support to protect employees at all fronts from the pandemic.

“At Siemens, the safety and wellbeing of our employees are of the utmost importance, and no efforts will be spared in ensuring that they receive all the support they need,” said Erdal Elver, President and Chief Executive Officer of Siemens Limited. “Siemens is keen to provide a safe workplace that protects our employees as well as their families. We believe the measures in place will reinforce the immunity barrier in Hong Kong and ultimately accelerate our recovery from the pandemic as a collective.”
