

Siemens Smart Gear Mobile Data Privacy Policy

Protecting the security and privacy of your personal data is important to Siemens; therefore, we conduct our business in compliance with applicable laws on data privacy protection and data security. We hope the policy outlined below will help you understand what data Siemens may collect via this Application, how Siemens uses and safeguards that data and with whom we may share it.

Your Consent

By using the Application, you are consenting to our processing of your information as set forth in this Privacy Policy now and as amended by us. "Processing" means using cookies or your device's unique identifiers, or using, accessing, transferring, or otherwise coming into contact with information in any way, including, but not limited to, collecting, storing, deleting, using, combining and disclosing information. If you reside outside the United States your information will be processed as required by United States law.

Personal data

Through this Application as well as during registration, Siemens will collect certain personal data about you, as permitted by applicable laws and regulations. This information may include your name, address, telephone number, e-mail address, age, user name, password and other registration information.

Purpose of Use; Sharing

When you do provide us with personal data, we use it to provide the service for which the Application is intended, to respond to your inquiry, process your order or instructions, provide you access to specific information or offers, and/or to support our existing or potential customer relationship with you. We may store and process personal data (on our own or via a third party on our behalf) and share it with our worldwide affiliates to better understand your needs and how we can improve our products and services. We (or a third party on our behalf) may use personal data to contact you about a Siemens offer or to conduct online surveys. Personal data (including location

data) may be aggregated by us (or a third party on our behalf) to provide information and services to utility companies. We may share information about the voltage and frequency of the power supplied through the charging station, usage patterns (including charging levels, schedules, delays, and errors) with utilities, demand aggregators, engineering contractors, home builders, consultants, facility/fleet managers, and other third-party sources. We may share personal data with ad networks, carriers, data resellers, data analytics providers, government entities, operating systems/platform companies, and other applications. Depending on your use of the Application, personal data and information may be shared with social networks. Except as set forth above, or as set forth below under "Purpose Limitation", we do not sell or otherwise market your personal data to third parties, except to Siemens affiliates, to service providers, and as described herein.

Other than information voluntarily disclosed, the Application is not currently configured to allow collection of personally identifiable information over time and across different Web sites about an individual's online activities.

Personal data is stored on cloud-based servers that may be operated by third-parties. This Application, via the cloud-based servers or otherwise, may store and transmit Personal Data.

Purpose Limitation

Siemens may collect, use or disclose personal data supplied by you for those purposes that have been disclosed to you, and for any additional purpose that is directly related to the original purpose for which the personal data was collected, as well as to the extent required by law or the competent governmental or judicial authorities, to establish or preserve a legal claim or defense, and to prevent fraud or other illegal activities, such as willful attacks on Siemens information technology systems.

Communication-related or usage-related data

When you access the Application via telecommunications services, communication-related data (e.g., Internet Protocol address) and usage-related data (e.g., data on the commencement and duration of usage and on the telecommunications services used by you) are automatically generated by technical means. This data could possibly enable inferences concerning your personal data. Whenever it is absolutely necessary to collect, process and use your communication-related or usage-related data, such activity is conducted in compliance with the laws and regulations applicable to data protection.

Information Stored Automatically on Your Computer or Device

We may read or store some data on your computer or device in the form of a unique identifier to automatically recognize your computer or device next time you visit. Unique identifiers can help us in many ways, for example, by allowing us to tailor the Application or a Web site to better match your interests or to store your password to save you having to re-enter it each time.

Children

Siemens will not knowingly collect personal data from children without insisting that they seek prior parental consent if required by applicable law. We will only use or disclose personal data about a child to the extent permitted by law, to seek parental consent pursuant to local law and regulations or to protect a child. The definition of "child" or "children" should take into account applicable laws as well as national and regional cultural customs.

Security

To protect your personal data against accidental or unlawful destruction, loss or alteration and against unauthorized disclosure or access, Siemens uses technical and organizational security measures.
