Siemens Canada will maintain the current TurboCare workforce of more than 50 employees at locations in Calgary and Edmonton. "Our employees are the heart of this service organization and are our greatest asset," said Gross.

TurboCare Canada, Ltd. was originally acquired by Siemens in 2006 (then Kadon) and specializes in the practical application of advanced repair, engineering, and maintenance technologies to solve industrial machinery problems, with a focus on electric motor repairs, turbomachinery, and mechanical and electrical engineering services. The company's 30-year success in the region speaks to the solid reputation Siemens Canada is looking for in its acquired businesses.

The integration of TurboCare not only strengthens the Siemens brand, but also presents a simplified approach for customers in the region requiring local customer service and support. The integration of TurboCare makes the Calgary repair centre location the eighth Siemens Industrial Sales and Service Centre in the country.

In November 2011 Siemens Canada acquired Prairie West Technical Services, a large service organization with facilities in Saskatchewan and Ontario.
