Features & Enhancements

PSAIM™ 1.5 with RBI contains the following features and enhancements:

PSAIM RBI module

The PSAIM RBI Module is integrated into PSAIM 1.5 and incorporates over 15 year of development by Siemens and TWI. It automates the fully quantitative methods and procedures of risk-based inspection (RBI) in process plants, according to API RP 580, API RP 581 and semi-quantitative assessment as per industry best practice. It is used to enable the facility operators or owners to establish an optimum inspection strategy; inspection programs; and take maintenance decisions. The PSAIM RBI Module will be sold as a separately priced option which is turned on from the license file and requires PSAIM 1.5 license by the customer.

Calculations - MAOP & Reports

MAOP Calculations and reports for ASME B31.1, B31.3, B31.4, B31.8, B31.11, S8/D1, S8/D2, API 650 CS & SS for determining the limiting pressure from last known thickness.

Calculations - Localized Corrosion

Localize corrosion calculation for Pipe based on B31G. This analysis is used for evaluation of localized corrosion to check the integrity of pipe.

Calculations - Flange ASME

Check the flange rating based on ASME B16.5 to determine the limiting pressure of the Eq/Circ ID.

Calculations - Piping Structural T-min

Beam formula calculator for user input. Piping Size Index chart with nominal thickness and schedules. User option to use API 574 recommended target and default Structural T-Mins.

Updated the Material Stress Tables with 2014 & 2016 ASME B31.x, 2017 BPVC.
