## Controller and categories of personal data

Siemens collects and processes the following personal data provided by you as:

- your contact information including your full name, identification number, position (if relevant), business addresses and e-mail;
- company's banking information.

## Purpose of the processing

Your data are collected and processed for the following purposes:

- marketing information.
- conferences invitations.
- Processing payments performed by company.

# **Retention Periods**

We store your personal data for a maximum period of 10 years unless a longer storage is strictly necessary in relation to the purposes for which they were collected or otherwise processed or statutory retention obligations under applicable law (such as tax or commercial law) require us to further retain personal data.

#### Recipients

For the purposes outlined above your data may be transferred to and processed by entities on behalf of Siemens AG (including related companies to Siemens AG or other service providers) in Israel and/or abroad.

Recipients of your personal data may possibly be located in countries outside of the European Economic Area, in which applicable laws do not offer the same level of data protection as the laws of your home country (each a "**Third Country**").

In such cases, Siemens takes measures to implement appropriate and suitable safeguards for the protection of personal data by other means.

- We share your personal data with Siemens companies in Third Countries only if they
  have implemented the Siemens Binding Corporate Rules (BCR) for the protection of
  personal data.
